## **Objectives of the NGO ''Sustainable World Peace''**

## **Principles:**

- Reinforcement of the peace discourse in order to promote world peace
- Support for international peace activists with emphasis on Catalonia, Spain, the Eurozone, and the Middle East
- Collect and provide humanitarian assistance to victims of violence and war
- Defending human rights values to promote world peace

## Implementation method:

- 1. Attempts to create justice and unity, peace and tranquility in the international community based on mutual respect for thoughts, religions, and nations
- 2. Support for the Universal Declaration of Human Rights December 1948 General Assembly of the United Nations and efforts to implement its provisions based on the traditions and cultural, religious, and social values of each country
- 3. To encourage governments to comply with international human rights laws and regulations and defend the rights of nations
- 4. Collaborate with international, governmental and non-governmental institutions, UNESCO, etc., as well as cooperate with the related NGOs.
- 5. Attempts and efforts to eliminate any discrimination based on color, race, nationality, and language
- 6. Attempts to eliminate the manifestations of tyranny, colonialism, and human exploitation of humans in various ways, including increasing the level of public awareness and popular participation in determining their political, social, cultural, and economic destiny
- 7. Active and comprehensive presence in the legal defense areas of human transcendental values in domestic and international assemblies and references
- 8. Attending world international forums in line with the peace dialogue plan, and promoting it in the intended regions
- 9. Establish coordination between the authorities of the countries in order to address the common discourse in the field of peace
- 10. Defending the rights of human beings everywhere in the world who have been abused, oppressed and wronged. The organization duly informs its objections and proposals to the competent authorities and organizations of domestic and international, and also world public opinion.
- 11. Assisting and identifying affected and vulnerable individuals and areas, educating and raising awareness in the field of avoiding violence and extremism in any field.
- 12. Efforts to expand the principles of justice and dignity in the international community and to prevent the violation of human rights under pressure and with political and military tactics
- 13. Production of content, films, ... in order to increase awareness and culture and strengthen ideas against violence and war, tribalism, sectarianism and ...
- 14. Holding seminars, conferences, exhibitions, training workshops and publishing publications in the form of periodicals, monthly magazines, weekly magazines, etc. in line with the goals of the organization
- 15. Protecting and defending the rights of victims of violence and social victims
- 16. Providing consultation services regarding the rehabilitation of social victims of war and violence and introducing them to the relevant centers to enjoy this type of service.
- 17. Use of influential people in different regions and countries to synchronize and consolidate various voices against oppression, war, violence and discrimination around the world
- 18. Using professors, experts and academic specialists to attend and train in vulnerable areas
- 19. Using celebrities (cinema, sports, culture, etc.) in line with the goals of the organization and strengthening the convergence and synchronicity in the path of sustainable world peace
- 20. Education and public awareness of the society and especially the societies affected by the culture of violence in order to achieve world peace and avoid war, discrimination and violence
- 21. Establish and facilitate communication with national, regional and international co-target organizations and provide opportunities for exchange of views and transfer of knowledge and experience
